**ORDINANCE NO. 1604**

**AN ORDINANCE AMENDING CHAPTER 330, VEHICLES AND TRAFFIC, ARTICLE IV, SNOW AND ICE EMERGENCY, OF THE UPPER MORELAND TOWNSHIP CODE OF ORDINANCES TO REVISE, AMEND AND RESTATE THE HIGHWAYS AFFECTED BY A DECLARATION OF A SNOW AND ICE EMERGENCY AS SNOW EMERGENCY ROUTES; REQUIRING THE POSTING OF SIGNS, AND REPEALING ORDINANCES INCONSISTENT WITH THESE AMENDMENTS**

**WHEREAS**, the Pennsylvania Traffic Code, at section 6109, 75 Pa.C.S.A. 6109 delegates certain powers to local authorities such as the Township of Upper Moreland the power to prescribe certain traffic requirements in the exercise of their reasonable exercise of the police powers, and

**WHEREAS**, The Board of Commissioners of Upper Moreland Township now desires to exercise its reasonable police powers to regulate the traffic flow in the Township during snow and ice emergencies for the safety of the residents, passersby, and travelers within the Township,

**NOW THEREFORE**, the Board of Commissioners of Upper Moreland Township does enact and ordain as follows:

**SECTION 1. Chapter 330, "Vehicles and Traffic,"** of the Upper Moreland Township Code is hereby amended by revising and amending Article IV, "Snow and Ice Emergency," so that section 330-28, "Highways Affected," now reads as follows:

The highways or portions thereof to which the provisions of this article shall be applicable during all periods of emergency declared as provided in the first section of this article [Article IV, section 330-25] shall be the following named streets or portions thereof when duly posted:

Bensal from Exton to Newton  
Blair Mill from Welsh to County Line  
Brook from York to the PW Yard  
Byberry from Pioneer to Warminster  
Centennial from Pioneer to County Line  
Center from Moreland to York  
County Line from Blair Mill to UMT border  
County Line from Warminster to Short (UMT border)  
Davisville from Moreland to County Line

Division from Moreland to Greyhorse  
Easton from Blair Mill to Moreland  
Edgehill from Moreland to Huntingdon  
Exton from Davisville to Bensal  
Fitzwatertown from Moreland to York  
Greyhorse from Division to Terwood  
Horsham from Blair Mill to Castello (UMT border)  
Huntingdon from Terwood to Edgehill  
Mill from Easton to York  
Moreland from Blair Mill to Edgehill  
Newton from Bensal to Warminster  
Orangemans from Byberry to Pioneer  
Overlook from Davisville to Edgehill  
Pioneer from Byberry to Davisville  
Pioneer from Orangemans to Centennial  
Terwood from York to Paper Mill (UMT border)  
Warminster from York to County Line  
West Moreland from Blair Mill to Flamingo (UMT border)  
York from Moreland to Newington (UMT border)

**SECTION 2. Severability.** In the event that any section, sentence, clause, phrase or word of this Ordinance shall be declared illegal, invalid or unconstitutional by any court of competent jurisdiction, such declaration shall not prevent, preclude, or otherwise foreclose enforcement of any of the remaining portions of this Ordinance.

**SECTION 3. Repealer.** All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.

**SECTION 4.** Appropriate signage is to be installed to reflect this Ordinance.


**SECTION 5.** This Ordinance shall be effective in accordance with law.
