Public Health & Safety Committee Members: Commissioner and Committee Chair Charles M. Whiting, Commissioner Kip McFatridge, Commissioner Jared Jacobs; Scott Bendig, Police Chief; Edward Glassman, Fire Chief; Kenneth E. Davidson, Assistant Chief Operations & Administration - Second Alarmer's Rescue Squad (SARS)

- I. **Call to order:** Commissioner and Committee Chair Charles M. Whiting called the meeting to order.
- II. **Pledge of Allegiance**
- III. **Roll Call:** Commissioner and Committee Chair Whiting, Commissioner McFatridge and Commissioner Jacobs. Fire Captain John Fugelo in the absence of Fire Chief Glassman, Police Chief Bendig, SARS Assistant Chief Davidson. Also present: Patrick T. Stasio, Township Manager, and Sean Kilkenny, Township Solicitor.
- IV. **Announcements:**
Commissioner Whiting asked everyone to keep Chief Ed Glassman in their thoughts during this time of difficulty with the loss of his mother.
- V. **Public Comments – Non-Agenda Items Only** – Nothing to report.
- VI. **Approval of Minutes – October 20, 2025:**
The Committee unanimously approved the meeting minutes as submitted.
- VII. **Acceptance and approval of the following monthly reports – October 2025:**
 - A. Police Department – Memorandum and Monthly Reports: Police Chief Bendig reviewed statistics and details on the following:
 - Service calls, criminal investigations, traffic enforcement, incidents, Bus Patrol violations, robberies, assaults, trainings and community events.
 - Township Santa Run will be held on December 7th.
 - Shop With A Cop will be held on December 4th at Walmart.
 - Commissioner Whiting inquired about minority officers. Chief Bendig stated that there is one officer that identifies as more than one race. Efforts continue to diversify hiring through participation in the Consortium and by circulating information to the community.
 - B. Department of Emergency Services – Fire Captain Fugelo reviewed the following items in the report:
 - Service calls, significant incidents, permits, inspections, fees collected, Fire Marshall investigations, trainings and community events.
 - Explained the initiative to encourage high school youth to volunteer.
 - Commissioner Whiting inquired about minority career personnel. Captain Fugelo stated that there are none; however, there are two volunteers.
 - Safety tip is to defrost thanksgiving turkeys before placing them in a deep fryer.
 - Christmas tree stump need a fresh cut at home, kept watered, and disposed from the house once it becomes dried out.
 - C. Second Alarmer's Association and Rescue Squad – SARS Assistant Chief Davidson reviewed the following items in the report:
 - Calls for service, transports, staffing crisis, fund drive subscriptions, and a new

- ambulance getting outfitted.
- Took delivery of a \$375,000 ambulance, which is being outfitted with equipment.
- Encouraged the public to join EMS and attend the next session of classes, which start on January 27, 2026.
- Asked for public support of House Bill 1152, which provides patient protection, direct payment to EMS and a State-regulated fee schedule.
- Commissioner Whiting inquired about minority representation in SARS. Chief Davidson stated that there is no required question on their employment application; however, there appears to be two employees, but could possibly be more.

- Commissioner McFatridge inquired about how many police officers are on the street during the day. Chief Bendig stated there are usually four officers, plus one supervisor, as well as the Traffic Safety Unit. There have been 20,000 calls estimated for 2025, up 10% compared to 2024.
- Commissioner Whiting stated gratitude to all the members of Ward 3 for electing him as their commissioner for the past eight years. He commented that the Township has been a Class A Township since 1930 and not until 2017 was an African-American elected as a commissioner. Youth in schools look to the local officials as community role models who can inspire careers for minorities.

The Upper Moreland Police Department responded to 1,771 calls for service in December 2025. The following Part-One Crimes were reported and investigated by the police department in December 2025, including:

NOTABLE INVESTIGATIONS:

BURGLARY INVESTIGATION:

In November 2025, several reports were received from individuals regarding commercial burglaries of their storage lockers within the Township. Suspects were identified after investigators linked an associated vehicle found in close proximity to the businesses at the time of the burglaries. The suspects identified were found to be connected to other storage locker burglaries in the region and to illegal firearms trafficking. This investigation was adopted by the Montgomery County Gun Violence Reduction Task Force. On December 11, 2025, with assistance from various partner agencies and Delaware County SWAT, three search warrants were served at locations in Clifton Heights, PA. On December 12, 2025, investigators recovered stolen property in the area of an address associated with one of the persons of interest. This investigation remains active, with charges expected at the conclusion.

ASSIST WITH HOMICIDE INVESTIGATION:

On December 15, 2025, the department was advised of an active homicide warrant for a juvenile who was known to reside within Upper Moreland Township. Investigators discovered this juvenile was enrolled within the School District but had not been attending school since shortly after the shooting in Norristown. Investigators obtained critical information about this individual, including his potential whereabouts. This information was forwarded to the Montgomery County District Attorney's Office Detective Division and other Federal partners, which led to the offender being located and arrested in Newark, NJ.

CHECK FRAUD INVESTIGATION:

On December 17, 2025, an investigation was initiated into the fraudulent cashing of a check issued by Upper Moreland Township. It was discovered that a check issued by the Township on October 29, 2025, was intercepted and diverted from the postal service. This check was subsequently altered and deposited into a Capital One bank account in New York. Investigators coordinated with fraud investigators between the Township's depositor and Capital One. Capital One froze the fraudulently deposited funds and returned them to the Township's depositor. Additionally, Capital One fraud investigators provided financial records and video recordings related to this transaction. The account holder who was involved in depositing this altered check was identified and interviewed in Newark, NJ. During this interview, other parties within the organization were identified. This investigation remains active with criminal charges expected at the conclusion.

NOTABLE INVESTIGATIONS:

COMMERCIAL BURGLARIES:

In late October and early November, a series of burglaries occurred at the Carr & Duff facility on Byberry Road. During these incidents, individuals cut through a fence from the direction of Mason Mill Park to enter a secured storage yard. Once inside, subjects stole copper wire, tools, and other supplies, and on one occasion attempted to take a work truck. Members of the Criminal Investigation Division conducted a comprehensive review of surveillance footage from the business and surrounding properties. Through this effort, they linked the burglaries to a trespassing incident in Mason Mill Park, where a U-Haul van became stuck and required a tow truck to remove it. Using license plate recognition cameras in the area, officers identified the tow truck that responded to the park. Investigators contacted the tow truck operator, who provided information, including the phone number used to request the tow and dash-cam footage showing two of the individuals involved.

A search warrant was later executed with U-Haul, which supplied the rental information for the van. This led to the identification and interview of a suspect, who admitted involvement in the thefts. The suspect also consented to a forensic download of his cell phone to help identify additional individuals connected to the series of burglaries.

SEXUAL ASSAULT INVESTIGATION:

In May 2025, Members of the Criminal Investigation Division began investigating the sexual assault of a minor in the Hatboro section of Upper Moreland Township. The suspect, an adult male experiencing homelessness with prior convictions for sexual offenses, was identified early in the investigation and arrested in June 2025. As the case progressed, investigators learned of a second minor victim. A separate investigation was launched, during which the child was interviewed through Mission Kids, a child-advocacy center specializing in forensic interviews. Investigators also conducted a forensic download of the second victim's cell phone to gather additional evidence.

In November 2025, the investigative team presented the combined findings to the Montgomery County District Attorney's Office. Prosecutors approved charges, including Statutory Sexual Assault and related offenses. The suspect remains in custody at the Montgomery County Correctional Facility while awaiting trial on both cases.

FUGITIVE INVESTIGATION:

In July 2025, police responded to a parking complaint at the Willow Grove Shopping Center. While checking the vehicle involved, officers noticed an unsecured handgun inside. The firearm was safely recovered, and the individual connected to the vehicle was identified as someone prohibited from possessing a gun due to an active fugitive warrant out of Florida.

The case was assigned to members of the Criminal Investigation Division and adopted by the Montgomery County Gun Violence Reduction Task Force. The firearm was submitted for forensic testing, including entry into the National Integrated Ballistic Information Network (NIBIN). The results linked the gun to a 2023 shooting in Philadelphia of a 5-year-old child.

An arrest warrant was issued, and investigators repeatedly attempted to secure the suspect's voluntary surrender. When he refused to cooperate, a fugitive investigation was launched. This effort involved extensive collaboration between local investigators, the Montgomery County Detective Bureau, and the Pennsylvania State Police. With court authorization, the team tracked the suspect's cell phone, ultimately locating him at an apartment building in Center City, Philadelphia.

Search warrants were obtained for information and surveillance footage from the building. Investigators learned the suspect was fraudulently occupying two separate apartments. Pennsylvania State Police Special Emergency Response Team (SERT) executed simultaneous high-risk warrant services, locating the suspect inside one of the units. During the searches, investigators uncovered a large-scale mail theft and bank fraud operation. Hundreds of stolen pieces of mail, more than a million dollars in fraudulent bank withdrawal documents, blank checks, credit card blanks, and equipment used to manufacture fraudulent financial documents were recovered. A "ghost" AR-style pistol was also seized.

The investigation into the stolen mail, financial fraud, and recovered firearm remains ongoing and is now being handled jointly by the Pennsylvania State Police and the U.S. Postal Inspection Service.

Background/Analysis:

Section 330-9 of the Township Code currently restricts the operation of tractors and trailers on designated streets. Following a comprehensive review by the Department's Traffic Safety Unit and an audit of applicable roadways, the Police Department recommends amending this section to improve clarity and enforcement. The proposed amendment would adopt the definition of "Commercial Motor Vehicle" as established in Title 75 of the Pennsylvania Motor Vehicle Code for purposes of this section, ensuring consistency with state law. In addition, the title of Section 330-9 would be amended to "No Truck Traffic" to reflect the restriction more accurately. The revised language would state that no commercial motor vehicles shall enter upon or be operated on the designated streets or portions thereof, and clarify that school buses, local deliveries, and emergency vehicles are not considered trucks or commercial motor vehicles for the purposes of this section. Finally, the list of streets subject to the restriction would be updated in accordance with the attached memo from Traffic Safety Officer Misner, ensuring that the designations reflect current roadway conditions and traffic safety needs. These changes will provide clearer guidance to motorists, align Township regulations with state definitions, and enhance enforcement of truck traffic restrictions.

In order to further clarify what types of vehicles are restricted by "No Trucks" signs, the TSU believes that the Township should adopt the definition of "Commercial Motor Vehicle" established in Pennsylvania Title 75 – Section 1603: **any vehicle, or combination of vehicles, with an actual weight or gross vehicle weight rating (GVWR) in excess of 26,000 lbs. School busses will not be considered a truck or "Commercial Motor Vehicle" as it pertains to this section.**

The intention of this clarification and update is to restrict large truck traffic from cutting through residential neighborhoods – particularly those neighborhoods that are located between two or more State Highways. The identified roadways either allow on-street parking that prohibits the safe travel of large truck traffic, or present topographical and terrain features that are not conducive to large vehicles on the roadway. The majority of the township's "no outlet" streets were not included in the recommendation where properly posted.

Background/Analysis:

Section 330-22 of the Township Code currently restricts parking on a designated portion of Orangemans Road in front of Upper Moreland Middle School during arrival and dismissal hours to enhance student safety and maintain traffic flow. However, despite this restriction, vehicles continue to stop and stand in the no-parking zone during these critical times, undermining the ordinance's intent and posing ongoing safety risks to students and school personnel. To strengthen enforcement and improve compliance, the Police Department recommends amending Section 330-22 to remove the Orangemans Road restrictions in front of the school and amending Section 330-24.1, which governs stopping or standing restrictions during certain hours, to include the affected portion of Orangemans Road. This change will allow officers to take enforcement action against vehicles that stop or idle in the zone, closing the gap left by the current parking-only language. By aligning stopping and standing restrictions with existing prohibitions, the amendment will reinforce the safety perimeter around the school, reduce traffic congestion during peak hours, and ensure the ordinance better serves its purpose of protecting students and maintaining orderly traffic flow.
