**Public Health & Safety Committee Meeting**

**Public Health & Safety Committee Members:** Commissioner and Committee Chair Charles M. Whiting, Commissioner Kip McFatridge, Commissioner Nicolas O. Scull; Andrew J. Block, Chief of Police; Edward Glassman, Fire Chief; Kenneth E. Davidson, Assistant Chief Operations & Administration - Second Alarmer's Rescue Squad

- I. **Call to order:** Commissioner and Committee Chair Charles M. Whiting called the meeting to order following adjournment of the Finance & Administrative Committee Meeting.
- II. **Roll Call:** Commissioner and Committee Chair Whiting, Commissioners McFatridge and Scull, Police Chief Block, Assistant Chief Davidson. Absent: Fire Chief Glassman. Also present were: Randall Schaible, Assistant Township Manager/Director of Finance, Matthew H. Candland, Township Manager, Alex Baumler, Township Solicitor.
- III. **Approval of Minutes** – April 18, 2022 - The meeting minutes were unanimously approved as submitted.
- IV. **Acceptance and approval of the following monthly reports - April 2022:**
  - A. Police Department – Memorandum and Monthly Reports - Chief Block discussed the following:
    - Statistics from calls, crimes, offenses, arrests, investigations, citizen concerns and traffic.
    - A list of community-oriented police activities and officer trainings was also reviewed.
  - B. Department of Emergency Services – Nothing additional to report.
  - C. Second Alarmer's Association and Rescue Squad - Chief Davidson reviewed the following:
    - Statistics for emergency responses, opioid incidents, transports, patients' outcomes, yearly comparisons, staffing, trainings and funding.
    - Five full-time paramedic positions remain vacant.
    - Notified by The Pennsylvania Department of Community and Economic Development (DCED) that certification was approved and \$37,237 will be allocated equally to all EMS agencies within the state of Pennsylvania provided by the \$25M Act 10 Legislation.
    - A grant application to American Rescue Plan Act (ARPA) was submitted to provide funding for consultants services to research information to advise further on the development of a regional EMS Authority.
    - Commissioner Spearing requested that the Board of Commissioners be included in the process. Chief Davidson explained that the application was expedited pursuant to directives from the last Committee Meeting, meetings with Representatives Guenst and Sanchez, and an approaching deadline.
    - Commissioners Prousi and Scull commended the SAARS Board for initiating an acquisition of information on developing an authority.
    - Commissioner Whiting reminded that all parties be in communication with each other.
- V. **Old Business** – Nothing to report.

**VI. New Business:**

- A. Memorandum of Understanding (MOU) - Montgomery County SWAT and Central Bucks Special Response Team:**
  - Commissioner Prousi inquired on additional proposed joint ventures with departments or institutions. Chief Block replied that there is a potential MOU with the DUI task force.
  - The Committee recommends the Board of Commissioners take action at the June 6, 2022 Regular Meeting.
- B. BUSPATROL – Traffic Management System:**
  - Chief Block explained that the camera system will record and report school bus violations for the Police Department to issue citations. There is no cost and participation is required by the School District with the Police Department. From the total of each citation, the Police Department receives \$25, the School District receives \$100 and BusPatrol collects the remaining balance.
  - Commissioner Whiting inquired about informing the public. Chief Block replied that media bits will be projected and announcements provided from the School District. Also, proposing a grace period during the first months, where warnings be given out.
  - Commissioner Spearing commented on the need for safety cameras inside school buses.
  - The Committee approved and recommends the Board take action at their June 6, 2022 Regular Meeting.
- C. Newington Drive – Parking Signs:**
  - Residents of Newington Drive requested a review of their concerns regarding the removal of street signs, safety and devaluation of their properties.
  - Commissioner Spearing commented concerns on parking in the intersection, which is a violation.
  - Mr. Baumler advised that the Ordinance must be advertised at least 10 days prior to moving forward.
  - The Committee recommends the Board of Commissioners take action at the July 11, 2022 Regular Meeting.

**May 2022 Monthly Report**

The Upper Moreland Police Department responded to 1,485 calls for service for the month of May 2022. The total calls for service for 2022 year to date is 6,450.

The calls for service between April and May of 2022 increased by 241 incidents. The monthly police department call volume has realized an 11.5% increase in call volume when comparing May 2021 and May 2022.

Outlying year-to-date call volume:

- May 2021; 5,777
- May 2020; 5,520
- May 2019; 5,995

Overall difference between year to date May 2019 and May 2022 is a 7.5% increase in call volume.

The following Part-One Crimes were reported and investigated by Upper Moreland Police in May 2022;

- One Automobile Theft
- 55 Theft offenses with 20 offenses cleared by arrest



**ORDINANCE NO. 22-\_\_\_\_\_**

**AN ORDINANCE OF UPPER MORELAND TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING PART II: GENERAL LEGISLATION, CHAPTER 153 "FIRE PREVENTION" TO THE UPPER MORELAND TOWNSHIP CODE OF ORDINANCES TO ADOPT PURSUANT TO THE PENNSYLVANIA CONSTRUCTION CODE ACT, THE 2018 INTERNATIONAL FIRE CODE APPLICABLE IN THE COMMONWEALTH OF PENNSYLVANIA; REPEALING ALL INCONSISTENT ORDINANCES, OR PARTS THEREOF IN CONFLICT THEREWITH; AND PROVIDING FOR A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE.**

**WHEREAS**, Upper Moreland Township, Montgomery County, Pennsylvania (hereinafter "the Township") is a Township of the First Class, organized and existing under the laws of the Commonwealth of Pennsylvania; and

**WHEREAS**, the Pennsylvania First Class Township Code (the "Code"), 53 Pa. C.S. § 1502(1), grants the Board of Commissioners the authority to enact certain regulations relating to the public health, safety and welfare of the citizens of the community of Upper Moreland Township; and

**WHEREAS**, the Township previously adopted provisions of the International Fire Code pursuant to the Pennsylvania Construction Code Act, 35 P.S. § 7210.101, *et seq.*, most recently adopting the 2015 set of codes issued by the International Code Council, as promulgated and amended by the Pennsylvania Department of Labor and Industry;

**WHEREAS**, the Department of Labor and Industry has adopted the 2018 version of certain codes of the International Code Council, as well as certain amendments thereto, as the Uniform Construction Code applicable in the Commonwealth of Pennsylvania; and

**WHEREAS**, the Board of Commissioners of Upper Moreland Township wishes to adopt the 2018 version of the International Fire Code Council as adopted by the Department of Labor and Industry as the codes applicable in Upper Moreland Township; and

**NOW, THEREFORE**, be it, and it is hereby **ORDAINED** by the Upper Moreland Township Board of Commissioners, and it is hereby **ENACTED** and **ORDAINED** by authority of same as follows:

**SECTION I: ADOPTION OF THE INTERNATIONAL FIRE CODE, 2018 EDITION.**

Upper Moreland Township hereby elects to administer the 2018 edition of the International Fire Code issued by the International Code Council as adopted by the Pennsylvania Department of Labor and Industry as part of the Uniform Construction Code, pursuant to the Pennsylvania Construction Code Act.

## **SECTION II: AMENDMENT OF THE CODE.**

The Upper Moreland Township Code of Ordinances, Part II General Legislation, Chapter 153 (Fire Prevention), Article II (Fire Prevention Code) Section 153-4 (Adoption of International Fire Code, 2015 Edition) is hereby stricken in its entirety and is amended to read as follows:

### **§ 153-4. Adoption of International Fire Code, 2018 Edition.**

It is hereby adopted by the Township of Upper Moreland, 117 Park Avenue, Willow Grove, Pennsylvania, that a certain fire prevention code shall apply to any situation where the requirements of the International Fire Code of 2018 are not referenced in the International Building Code of 2018 and administered and enforced under the Township's Pennsylvania Uniform Construction Code (UCC) program established in Chapter 115 of the Upper Moreland Township Code of Ordinances.

## **SECTION III: AMENDMENT OF THE CODE.**

The Upper Moreland Township Code of Ordinances, Part II General Legislation, Chapter 153 (Fire Prevention), Article II (Fire Prevention Code) Section 153-6 (Amendments to International Fire Code) Subsection C is hereby amended to read as follows:

### **§ 153-6. Amendments to International Fire Code.**

C. Section 103.2, Appointment, shall be amended to state the following:

**103.2 Code official.** The Fire Chief of the Township of Upper Moreland or duly appointed assistants shall be the code official as referred to in this code.

## **SECTION IV: SEVERABILITY.**

The terms, conditions and provisions of this Ordinance are hereby declared to be severable, and should any portion, part or provision of this Ordinance be found by a court of competent jurisdiction to be invalid, unenforceable or unconstitutional, the Upper Moreland Township Board of Commissioners hereby declares its intent that the Ordinance shall have been enacted without regard to the invalid, unenforceable, or unconstitutional portion, part or provision of this Ordinance.

## **SECTION V: REPEALER.**

Any and all other Ordinances or parts of Ordinances in conflict with the terms, conditions and provisions of this Ordinance are hereby repealed to the extent of such irreconcilable conflict.

## **SECTION VI: EFFECTIVE DATE.**

This Ordinance shall be effective five (5) days after enactment.
