Also present: Randy Schaible, Assistant Township Manager/Director of Finance, Matthew H. Candland, Township Manager, Sean Kilkenny, Township Solicitor.

 - A. **Motion to Approve** the conditional appointment of Mark A. Woltemate as a Probationary Police Officer. Such appointment is conditional upon successful completion of medical and psychological examinations:
 - Commissioner McFatridge motioned, seconded by Commissioner Lockard and the Board of Commissioners approved by a vote of 6-0.
 - Chief Block provided the background of Officer Woltemate's education and professional experience.

ORDINANCE NO. 1733

AN ORDINANCE OF UPPER MORELAND TOWNSHIP, MONTGOMERY COUNTY, PENNSYLVANIA, AMENDING PART II: GENERAL LEGISLATION, CHAPTER 287 “STORMWATER MANAGEMENT” TO THE UPPER MORELAND TOWNSHIP CODE OF ORDINANCES; REPEALING ALL INCONSISTENT ORDINANCES, OR PARTS THEREOF IN CONFLICT THEREWITH; AND PROVIDING FOR A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE.

WHEREAS, Upper Moreland Township, Montgomery County, Pennsylvania (hereinafter “the Township”) is a Township of the First Class, organized and existing under the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Pennsylvania First Class Township Code (the “Code”), 53 Pa. C.S. § 1502(1), grants the Board of Commissioners the authority to enact certain regulations relating to the public health, safety and welfare of the citizens of the community of Upper Moreland Township; and

WHEREAS, a comprehensive program of stormwater management, including minimization of impacts of development, redevelopment, and activities causing accelerated erosion and loss of natural infiltration, is fundamental to the public health, safety, welfare, and the protection of the people of the Township and all of the people of the Commonwealth, their resources, and the environment; and

WHEREAS, federal and state regulations require the Township to implement a program of stormwater controls. The Township is required to obtain a permit for stormwater discharges from their separate storm sewer systems under the National Pollutant Discharge Elimination System (NPDES); and

WHEREAS, certain federal and state regulations on stormwater discharges have been promulgated subsequent to the Township’s adoption of its Stormwater Management Ordinance which necessitates the Township to amend Chapter 287 of the Township’s Code of Ordinances to remain compliant with the current regulations.

NOW, THEREFORE, be it, and it is hereby **ORDAINED** by the Upper Moreland Township Board of Commissioners, and it is hereby **ENACTED** and **ORDAINED** by authority of same as follows:

SECTION 1: AMENDMENT OF CHAPTER 287, ARTICLE I OF THE CODE

Article I General Provisions, Chapter 287-2 “Statement of findings”, Subsection “A” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- A. Inadequate management of accelerated runoff of stormwater resulting from development throughout a watershed increases runoff volumes, flows and velocities, contributes to erosion and sedimentation, overtakes the carrying capacity of streams and storm sewers, greatly increases the cost of public facilities to carry and control stormwater, undermines flood plain management and flood control efforts in downstream communities, reduces groundwater recharge, threatens public health and safety, and increases nonpoint source pollution of water resources.

Article I General Provisions, Chapter 287-2 “Statement of findings” of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subsection “I”, which shall state the following:

- I. The use of green infrastructure and low impact development (LID) are intended to address the root cause of water quality impairment by using systems and practices which use or mimic natural processes to: 1) infiltrate and recharge, 2) evapotranspiration and/or 3) harvest and use precipitation near where it falls to earth. Green infrastructure practices and LID contribute to the restoration or maintenance of pre-development hydrology.

Article I General Provisions, Chapter 287-3 “Purpose”, Subsection “H” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- H. Manage stormwater runoff close to the source, reduce runoff volumes and mimic predevelopment hydrology.

Article I General Provisions, Chapter 287-3 “Purpose” of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subsection “S”, which shall state the following:

- S. Preserve natural drainage systems.

Article I General Provisions, Chapter 287, of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subchapter titled “§ 287-10.1 Erroneous Permit”, which shall state the following:

§ 287-10.1 Erroneous Permit

- A. Any permit or authorization issued or approved based on false, misleading or erroneous information provided by an applicant is void without the necessity of any proceedings for revocation. Any work undertaken or used established pursuant to such permit or authorization is unlawful. No action may be taken by a board, agency or employee of the Township purporting to validate such violation.

Article I General Provisions, Chapter 287, of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subchapter titled “§ 287-10.2 Waivers”, which shall state the following:

§ 287-10.2 Waivers

- A. If the Township determines that any requirement under this chapter cannot be achieved for a particular regulated activity, the Township may, after an evaluation of alternative, approve measures other than those in this chapter, subject to paragraphs B and C in this section
- B. Waivers or modifications of the requirements of this chapter may be approved by the Township if enforcement will exact undue hardship because of peculiar conditions pertaining to the land in question, provided that the modifications will not be contrary to the public interest and that the purpose of the chapter is preserved. Cost or financial burden shall not be considered a hardship. Modification may be considered if an alternative standard or approach will provide equal or better achievement of the purpose of the chapter. A request for modifications shall be in writing and accompany the Stormwater Management Site Plan submission. The request shall provide the facts on which the request is based, the provision(s) of the chapter involved and the proposed modification.
- C. No waiver or modification of any regulated stormwater activity involving earth disturbance greater than or equal to one acre may be granted by the Municipality unless that action is approved in advance by the Department of Environmental Protection (DEP) or the delegated county conservation district.

SECTION 2: AMENDMENT OF CHAPTER 287, ARTICLE II OF THE CODE

Article II Definitions, Chapter 287-12 “Terms Defined” of the Upper Moreland Township Code of Ordinances is hereby amended to add the following new terms:

GREEN INFRASTRUCTURE: Systems and practices that use or mimic natural processes to infiltrate, evapotranspire, or reuse stormwater in the site where it is generated.

LOW IMPACT DEVELOPMENT (LID): Site design approaches and small-scale stormwater management practices that promote the use of natural systems for infiltration, evapotranspiration, and reuse of rainwater. LID can be applied to new development, urban retrofits, and revitalization projects, LID utilizes design techniques that infiltrate, filter, evaporate, and store runoff close to its source. Rather than rely on costly large-scale conveyance and treatment systems, LID addresses stormwater through a variety of small, cost-effective landscape features located on-site.

PERVIOUS AREA: Any area not defined as impervious.

RIPARIAN BUFFER: A permanent area of trees and shrubs located adjacent to streams, lakes, ponds and wetlands.

Article II Definitions, Chapter 287-12 “Terms Defined” of the Upper Moreland Township Code of Ordinances is also hereby amended to state the following (text to be added shown as underline):

IMPERVIOUS SURFACE (IMPERVIOUS AREA): A surface that prevents the infiltration of water into the ground. Impervious surfaces (or areas) shall include, but not limited to: roofs; additional indoor living spaces, patios, garages, storage sheds and similar structures; and any new streets, driveways, or sidewalks. Impervious surfaces also include other areas determined to be impervious by the Township Engineer. The water surface within swimming pools shall not be considered an impervious surface.

SECTION 3: AMENDMENT OF CHAPTER 287, ARTICLE III OF THE CODE

Article III Stormwater Management (SWM) Site Plan Requirements, Chapter 287-13 “SWM Site Plan Contents” of the Upper Moreland Township Code of Ordinances is hereby amended to add new Subsections “E through K”, which shall state the following:

- E. Provisions for permanent access or maintenance easements for all physical SWM BMPs, such as ponds and infiltration structures, as necessary to implement the Operation and Maintenance (O&M) Plan discussed in this section.
- F. The following signature block for the municipality: “(Municipal official or designee), on this date (Signature date), has reviewed and hereby certifies that the SWM Site Plan meets all design standards and criteria of the Municipal Ordinance No. (number assigned to ordinance).”
- G. A determination of site conditions in accordance with the BMP Manual. A detailed site evaluation shall be completed for projects proposed in areas of carbonate geology or karst topography, and other environmentally sensitive areas, such as brownfields.
- H. Plan and profile drawings of all SWM BMPs, including drainage structures, pipes, open channels, and swales.
- I. SWM Site Plan shall show the locations of existing and proposed on-lot wastewater facilities and water supply wells.
- J. The SWM Site Plan shall include an O&M Plan for all existing and proposed physical stormwater management facilities. This plan shall address long-term ownership and responsibilities for O&M as well as schedules and costs for O&M activities.
- K. A justification must be included in the SWM Site Plan if BMPs other than green infrastructure methods and LID practices are proposed to achieve the volume, rate and water quality controls under this chapter.

Article III Stormwater Management (SWM) Site Plan Requirements, Chapter 287-15 “SWM Site Plan Review”, Subsection “B” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- B. The Township will notify the applicant, in writing, within 45 days, whether the SWM site plan is approved or disapproved. If the SWM site plan involves a subdivision and land development plan, the notification period is 90 days. If longer notification period is provided by other statute, regulation, or ordinance, the applicant will be so notified by the Township. If the Township disapproves the SWM site plan, the Township shall cite the reasons for disapproval in writing. **The Township also may approve the SWM site plan with conditions and, if so, shall provide the acceptable conditions for approval in writing.**

Article III Stormwater Management (SWM) Site Plan Requirements, Chapter 287 of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subchapter titled “§ 287-17.1 Authorization to Construct and Term of Validity”, which shall state the following:

§ 287-17.1 Authorization to Construct and Term of Validity

- A. The Township’s approval of an SWM Site Plan authorizes the regulated activities contained in the SWM Site Plan for a maximum term of validity of 5 years following the date of approval. The Township may specify a term of validity shorter than 5 years in the approval for any specific SWM Site Plan. Terms of validity shall commence on the date the Township signs the approval for an SWM Site Plan. If an approved SWM Site Plan is not completed according to § 287-17.2 within the term of validity, then the Township may consider the SWM Site Plan disapproved and may revoke any and all permits. SWM Site Plans that are considered disapproved by the Township shall be resubmitted in accordance with §287-17 of this chapter.

Article III Stormwater Management (SWM) Site Plan Requirements, Chapter 287 of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subchapter titled “§ 287-17.2 As-Build Plans, Completion Certificate & Final Inspection”, which shall state the following:

§ 287-17.2 As-Build Plans, Completion Certificate, & Final Inspection

- A. The developer shall be responsible for providing as-build plans of all SWM BMPs included in the approved SWM Site Plan. The as-build plans and an explanation of any discrepancies with the construction plans shall be submitted to the Township.
- B. The as-build submission shall include a certification of completion signed by a qualified professional verifying that all permanent SWM BMPs have been constructed according to the approved plans and specifications. The latitude and longitude coordinates for all permanent SWM BMPs must also be submitted, at the central location of the BMPs. If any licensed qualified professionals contributed to the construction plans, then a licensed qualified professional must sign the completion certificate.
- C. After receipt of the completion certification by the Township, the Township may conduct a final inspection.

SECTION 4: AMENDMENT OF CHAPTER 287, ARTICLE IV OF THE CODE

Article IV Stormwater Management Provisions, Chapter 287-18 “General Requirements”, Subsection “K” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- K. Normally dry, open top, storage facilities should completely drain both the volume control and rate control capacities over a period of time not less than 24 and not more than 72 hours from the end of the design storm.

SECTION 5: AMENDMENT OF CHAPTER 287, ARTICLE VI OF THE CODE

Article VI Fees and Expenses, Chapter 287-29 “Expenses covered by fees” of the Upper Moreland Township Code of Ordinances is hereby amended to add new Subsection “G”, which shall state the following:

- G. Attendance at Meetings

SECTION 6: AMENDMENT OF CHAPTER 287, ARTICLE VII OF THE CODE

Article VII Maintenance Responsibilities, Chapter 287-30 “Performance Guarantee”, Subsection “A” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- A. For subdivisions and land developments, the applicant shall provide a financial guarantee to the Township for the timely installation and proper construction of all stormwater management facilities as required by the approved SWM site plan and this chapter in accordance with the provisions of Sections 509, 510 and 511 of the Pennsylvania Municipalities Planning Code. The amount of the guarantee shall be equal to or greater than the full construction cost of the required controls.

Article VII Maintenance Responsibilities, Chapter 287-31 “Responsibilities for operation and maintenance (O&M) of stormwater facilities and best management practices (BMPs)”, Subsection “E” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- E. The Township shall make the final determination on the continuing O&M responsibilities. The municipality may require a dedication of such facilities as part of the requirements for approval of the SEM Site Plan. Such a requirement is not an indication that the municipality will accept the facilities. The Township reserves the right to accept or reject the O&M responsibility for any or all of the stormwater facilities and BMPs, and to require an easement for inspection and repair at the owner’s cost if privately owned.

Article VII Maintenance Responsibilities, Chapter 287-31 “Responsibilities for operation and maintenance (O&M) of stormwater facilities and best management practices (BMPs)” of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subsection “H”, which shall state the following:

- H. Facilities, areas, or structures used as SWM BMPs shall be enumerated as permanent real estate appurtenances and recorded as deed restrictions or conservation easements that run with the land.

Article VII Maintenance Responsibilities, Chapter 287-33 “Operation and maintenance (O&M) agreement for privately owned stormwater controls and BMPs” Subsection “A” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- A. The owner shall sign an O&M agreement with the Township covering all stormwater facilities and BMPs that are to be privately owned. The O&M agreement shall be transferred with transfer of ownership, as a covenant running with the land.
- (1) The owner, successor and assigns shall maintain all facilities in accordance with the approve maintenance schedule in the O&M Agreement.**
 - (2) The owner shall convey to the Township conservation easements to assure access for periodic inspections by the Township and maintenance, as necessary.**
 - (3) The owner shall keep on file with the Township the name, address, and telephone number of the person or company responsible for maintenance activities; in the event of a change, new information shall be submitted by the owner to the Township within ten (10) working days of the change.**

SECTION 7: AMENDMENT OF CHAPTER 287, ARTICLE VIII OF THE CODE

Article VIII Prohibitions, Chapter 287-35 “Prohibited discharges and connections”, Subsection “A” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

- A. Any drain or conveyance, whether on the surface or subsurface, that allows any non-stormwater discharge, including sewage, process wastewater, and wash water to enter a regulated small MS4 or to enter the surface waters of this commonwealth, is prohibited. Any connections to the storm drain system from indoor drains and sinks also are prohibited.

Article VIII Prohibitions, Chapter 287-35 “Prohibited discharges and connections”, Subsection “B” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

B. No person shall allow, or cause to allow, discharges into **a regulated small MS4, or discharges into** surface waters of this commonwealth which are not composed entirely of stormwater, except:

- (1) As provided in Subsection C below; and
- (2) Discharges allowed under a state or federal permit.

Article VIII Prohibitions, Chapter 287-35 “Prohibited discharges and connections”, Subsection “C” of the Upper Moreland Township Code of Ordinances is hereby stricken in its entirety and replaced with the following:

C. The following discharges are authorized unless they are determined to be significant contributors to pollution of a regulated small MS4 or to the waters of this Commonwealth:

- (1) Discharges or flows from firefighting activities.
- (2) Discharges from potable water sources including water line flushing and fire hydrant flushing, if such discharges do not contain detectable concentrations of Total Residual Chlorine (TRC).
- (3) Non-contaminated irrigation water, water from lawn maintenance, landscape drainage and flows from riparian habitats and wetlands.
- (4) Diverted stream flows and springs.
- (5) Non-contaminated pumped ground water and water from foundation and footing drains and crawl space pumps.
- (6) Non-contaminated HVAC condensation and water from geothermal systems.
- (7) Residential (i.e., not commercial) vehicle wash water where cleaning agents are not utilized.
- (8) Non-contaminated hydrostatic test water discharges if such discharges do not contain detectable concentration of TRC.

Article VIII Prohibitions, Chapter 287-35 “Prohibited discharges and connections”, Subsection “D” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

D. In the event that the municipality or DEP determines that any of the discharges identified in Subsection C significantly contribute pollution **to a regulated small MS4 or to** the waters of this commonwealth, the municipality or DEP will notify the responsible person(s) to cease the discharge.

Article VIII Prohibitions, Chapter 287-36 “Roof drains” of the Upper Moreland Township Code of Ordinances is hereby amended to state the following (text to be added shown as underline):

Roof Drains and sump pumps shall not be connected to streets, sanitary or storm sewers, or roadside ditches, and shall discharge to infiltrate areas or vegetative BMPs wherever feasible to the maximum extent practicable, unless otherwise approved by the Township Engineer.

SECTION 8: AMENDMENT OF CHAPTER 287, ARTICLE IX OF THE CODE

Article IX Enforcement and Penalties, Chapter 287-39 “Inspection” of the Upper Moreland Township Code of Ordinances is hereby amended to add a new Subsection “E”, which shall state the following:

- E. Inspections should be conducted during or immediately following precipitation events. A written inspection report shall be created to document each inspection. The inspection report shall contain the date and time of the inspection, the individual(s) who completed the inspection, the location of the BMP, facility or structure inspected, observations on performance, and recommendations for improving performance, if applicable. Inspection reports shall be submitted to the Township within 30 days following completion of the inspection.

Article IX Enforcement and Penalties, Chapter 287-40 “Enforcement” of the Upper Moreland Township Code of Ordinances is hereby amended to add new Subsections “D” and “E”, which shall state the following:

- D. It shall be unlawful for a person to undertake any regulated activity except as provided in an approved SWM Site Plan, unless specifically exempt in §287-6.
- E. It shall be unlawful to violate §287-37 of this ordinance.

SECTION 9: SEVERABILITY.

The terms, conditions and provisions of this Ordinance are hereby declared to be severable, and should any portion, part or provision of this Ordinance be found by a court of competent jurisdiction to be invalid, unenforceable or unconstitutional, the Upper Moreland Township Board of Commissioners hereby declares its intent that the Ordinance shall have been enacted without regard to the invalid, unenforceable, or unconstitutional portion, part or provision of this Ordinance.

SECTION 10: REPEALER.

Any and all other Ordinances or parts of Ordinances in conflict with the terms, conditions and provisions of this Ordinance are hereby repealed to the extent of such irreconcilable conflict.

SECTION 11: EFFECTIVE DATE.

This Ordinance shall be effective five (5) days after enactment.





ADDENDUM

JERC Partners XXXIX, LLC, also known as “Petrucci Residential” (the “Applicant”), was granted conditional use approval pursuant to Upper Moreland Township Resolution R-2017-09 (“Prior Conditional Use Approval”), as well as lot consolidation and land development approval by the Board of Commissioners, to construct a mixed-use, transit-oriented, mid-rise apartment and office/commercial development with a parking garage/structure, more commonly known as the “Station at Willow Grove” (the “Development”), on the property located at 73 N. York Road/91 N. York Road in Upper Moreland Township, more particularly identified as Montgomery County (consolidated) Tax Parcel No. 59-00-19807-00-6 (the “Property”). The Applicant is the owner of the Property, which is located in the Township’s “TC” Town Center District and consists of approximately 5.394 acres of land. The Applicant has nearly completed the Development at this time.

Pursuant to the Prior Conditional Use Approval, the Development is required to have “no less than 2,000 square feet of designated office and retail space on the first floor”, despite the fact that the Upper Moreland Township Zoning Ordinance (the “Zoning Ordinance”) permits mid- or high-rise apartments with a first floor having “no less than 2,000 square feet of office or retail uses”. The Applicant has intensely marketed the first-floor office/retail space for retail use, but has been unsuccessful in its efforts to obtain a retail tenant given current market conditions, perceived issues with parking, etc. As a result, the Applicant would like to use the entire 2,000 square feet for office use, consistent with the Zoning Ordinance. However, a technical reading of the Prior Conditional Use Approval indicates that such space must be used for office and retail uses, and the Township has preliminarily taken the position that some part of the 2000 SF minimum must be utilized for retail despite the language of the ordinance itself. Therefore, the Applicant is filing this Conditional Use Application to request a modification of the Prior Conditional Use Approval to permit office or retail within the 2,000 square feet on the first floor previously designated for such uses.

The Applicant does not believe that the requested modification will be contrary to the public health, safety, or welfare, particularly given the fact that the modification would align with the specific language in the Zoning Ordinance permitting a mid-rise apartment use (such as the Development) with office or retail. The Zoning Ordinance requirement was exactly the same at the time of the Prior Conditional Use Approval, and there is no indication in the Prior Conditional Use Approval as to why the designated first floor office/retail space is described as “office and retail” as opposed to “office or retail”. Notwithstanding, the Applicant has found it impossible to find a retail tenant for a portion of the space, given the significant changes in retail operations as a result of COVID-19 and the unusual parking situation for a retail tenant. In order to lease the space, therefore, the Applicant must be able to use the space for 100% office use, and an office tenant has already been located. The Applicant is therefore requesting a modification to align the Prior Conditional Use Approval with the requirements and express language of the Zoning Ordinance.

Based on the foregoing, the Applicant respectfully requests that the Board of Commissioners grant the requested modification to the conditional use approval granted by Resolution R-2017-09, and pursuant to Sections 350-260.B of the Upper Moreland Township Zoning Ordinance.
