Public Health & Safety Committee Meeting

Public Health & Safety Committee Members: Commissioner and Committee Chair Charles M. Whiting, Commissioner Kip McFatridge, Commissioner Anthony Benvenuti; Scott Bendig, Police Chief; Edward Glassman, Fire Chief; Kenneth E. Davidson, Assistant Chief Operations & Administration - Second Alarmers' Rescue Squad (SARS)

- I. **Call to order:** Commissioner and Committee Chair Charles M. Whiting called the meeting to order.
- II. **Roll Call:** Commissioner and Committee Chair Whiting, Commissioners McFatridge and Benvenuti. Fire Chief Glassman, Police Chief Bendig, SARS Assistant Chief Davidson. Also present was Patrick T. Stasio, Township Manager, and Sean Kilkenny, Township Solicitor.
- III. **Announcements**
- IV. **Approval of Minutes – October 28, 2024:**
The Committee unanimously approved the meeting minutes as submitted.
- V. **Acceptance and approval of the following monthly reports – October 2024:**
 - A. Police Department – Memorandum and Monthly Reports: Police Chief Bendig discussed the following:
 - Statistics and details from services, trainings, investigations, K-9 Unit and participation in community events contained in the report.
 - Speeding concerns on Huntingdon Road and options for solutions, based upon an examination of crash data and traffic study.
 - The Committee directed Police Chief Bendig to implement options discussed and determine the best result, before lowering the speed limit.
 - Commissioner McFatridge commented ongoing concern regarding 360 citations given to motorists each month who drive through school bus lights.
 - B. Department of Emergency Services – Fire Chief Glassman discussed the following:
 - Statistics and details from services, fees, participation in trainings and community events contained in the report.
 - Safety tips include using caution with deep fryers, and to check heaters, chimneys, smoke detectors and carbon monoxide detectors. Call the Fire Department for additional information relating to fire safety concerns.
 - C. Second Alarmers' Association and Rescue Squad: SARS Assistant Chief Davidson reviewed the following:
 - Statistics and details from services, staffing, trainings and community events in the report for the month.
 - Attended a meeting in Harrisburg on October 7th held by PA State Representatives Jill Cooper, Lisa Borowski and Barb Gleim regarding the balance billing legislation to protect patients and consumers left with high balances due to emergency medical services and plan to follow up with State Representatives at future meetings. The intent was to hold collaborative discussions with insurance companies and municipalities.
 - Governor Shapiro signed Senate Bill 365 on October 29th, which extends workman's

compensation benefits to all first responders, police, fire and emergency medical service providers who suffer from post-traumatic stress injuries attributed to work-related exposure. There is concern over the financial impact, which may affect workmen's compensation companies by either increasing rates or eliminating insurance to first responders, emergency medical service providers and other disciplines.

- Senate Bills 1132, 1133 and 1134 were passed for First Class and Second Class Townships and Boroughs, which allows municipalities to collect a dedicated ambulance or emergency medical services tax to be allocated toward salary and benefits.

A. Transfer of Relief Funds to the Volunteer Fire Company:

- Fire Chief Glassman explained that the Township received \$122,177.41 for Fireman's Relief from the State Fire Commissioners Office and requested that the Township transfer the funds to the new Upper Moreland Volunteer Fire Department Relief Fund.
- The Committee recommends the Board of Commissioners approve at the December 2, 2024 Regular Meeting.

VIII. **Other Items:**

A. Consider the cancellation of the December 16, 2024 Meeting:

- The Committee unanimously agreed to cancel the December 16, 2024 Public Health & Safety Committee Meeting.

November 2024 Monthly Report**

The Upper Moreland Police Department responded to 1,277 calls for service in November 2024, for a total of 14,551 calls for service year to date. The calls for service in November 2024 decreased 14% from the previous month. The comparative monthly police department call volume between November 2023 and November 2024 increased by 3.8%. Comparative year-to-date call volume:

- November 2024: 14,551
- November 2023: 14,013
- November 2022: 14,394
- November 2021: 13,091

The following Part-One Crimes were reported and investigated by the police department in November 2024:

- Three Burglaries
- Three Auto Theft
- 31 Theft offenses, with 19 cleared by arrest

The following Part-Two Crimes were reported and investigated by the police department in November 2024:

- Three Narcotics arrests
- Three Public Intoxication arrest

Notable Investigations

Death Investigation:

On November 1, 2024, officers responded to a residence on Warminster Road for an unresponsive subject. The subject was pronounced deceased, and the Criminal Investigations Division was notified. This death was suspected to be the result of a drug overdose. The scene was processed, and evidence was collected to link this overdose death to another reported overdose in the immediate vicinity at approximately the same time. This investigation remains active in an attempt to identify what substance was ingested and how the subject came to possess the substance.

Retail Theft:

On November 2, 2024, officers responded to the Walmart on Blair Mill Road for a retail theft in progress. Upon arrival, officers apprehended the subject in the parking lot. Further investigation revealed that the subject was responsible for at least eight additional retail thefts in the tri-state area totaling over \$10,000.00 in merchandise.

Burglary Investigation:

On November 6, 2024, patrol officers responded to a business in the 1100 block of Easton Road for a burglary in progress. Upon arrival, officers encountered a subject climbing off the roof of the apartment/business. The subject was detained. An interview with the apartment's tenant revealed that he arrived home to find the subject in his apartment. The subject was taken into custody. The Criminal Investigations Division responded and processed the scene. Multiple search warrants were executed in this investigation. The subject was charged with burglary and related offenses.

Megan's Law Violations:

On October 14, 2024, the department became aware that a Megan's Law offender who had absconded from supervision was residing with an associate at a home on Newton Road. This offender also had multiple outstanding arrest warrants for multiple jurisdictions. The Criminal Investigations Division initiated an investigation in an attempt to take the offender into custody. On November 13, 2024, the offender was located at the Walmart on Blair Mill Road. Officers attempted to conduct a traffic stop on the offender's vehicle. The vehicle failed to stop. Officers did not pursue the vehicle. The assistance of the United States Marshall's Office was requested, and surveillance was conducted to locate the offender. On November 20, 2024, a possible sighting of this offender was reported at the home on Newton Road. This reported sighting resulted in an exhaustive search of the area utilizing canines and drones. The offender was not located. On November 21, 2024, the offender was taken into custody without incident after surveillance located his vehicle entering a dead-end roadway. The offender was arrested and charged with various Megan's Law and related violations. An associate providing aid to this offender was also arrested and charged with hindering apprehension.

The Upper Moreland Police Department responded to 1,311 calls for service in December 2024, for a total of 15,862 calls for service in 2024. The calls for service in December 2024 increased by 2.6 % from the previous month. The comparative monthly police department call volume between December 2023 and December 2024 increased by 6.1%. Comparative year-to-date call volume:

- December 2024: 1,311

Notable Investigations

Package Theft Operation

On December 2, 2024, officers responded to a package theft on Gilpin Road. A high-valued iPad was stolen just after it was delivered to the residence. A home security video captured the theft. A suspect vehicle was identified using the license plate reader system. This suspect vehicle was connected with other package thefts in the tri-county area. On December 4, 2024, officers monitoring the license plate reader system received a notification that the suspect vehicle was in the area of Byberry Road and Philmont Avenue. This vehicle was located and stopped on Huntingdon Pike in Abington Township. The operator of this vehicle was found to be wearing the same clothing captured on the home security cameras from the day of the incident. Officers applied for and obtained a search warrant for the vehicle. Additional articles of clothing worn by the offender and other stolen package material were located within this vehicle. During an interview with the operator, he admitted to his involvement in the theft on Gilpin Road.

Investigation Update: Theft of High-End Vehicles Jamestown Village Apartments

In March 2024, officers took reports of the theft of two high-end performance vehicles from the Jamestown Village Apartments. Both vehicles were later recovered in New Jersey. Information was recently received that ten individuals were federally indicted for their involvement in a vehicle theft ring operating in the tri-state area. DNA evidence from one of the vehicles was submitted for analysis. The recovered DNA profiles were forwarded to the Pennsylvania State Police's Bureau of Criminal Investigation, Central and Eastern Auto Theft Task Forces, and the Federal Bureau of Investigation. This DNA profile matched the DNA of one of the subjects indicted, resulting in the clearance of our vehicle thefts.

Robbery

On December 11, 2024, officers responded to Smokers Destiny Vape Shop on Easton Road for a robbery that had just occurred. Upon arrival, officers spoke with the employee, who advised that a subject wearing dark clothing and a mask entered the store and displayed a firearm, demanding cash. The subject fled on foot after receiving \$200.00 cash. A canine track was initiated, ending where the subject parked a vehicle. This investigation is ongoing.

Homicide Arrest

On December 17, 2024, officers responded to the area of Junk Luggers on Davisville Road for a report that an employee who was wanted for a recent home invasion and homicide in Lower Merion Township was on location. Officers responded to the area and located the wanted subject walking away on the SEPTA rail tracks. The subject was taken into custody without incident and transported to the station, where personnel assisted the Montgomery County Detective Bureau and Lower Merion Detectives with their investigation.

Domestic Terrorism Arrest

Throughout the fourth quarter of 2024, officers assisted the Federal Bureau of Investigation with a threat investigation involving an individual who was found to be communicating with others across the United States in a domestic terrorism plan. This individual was found to be conspiring and providing operational information into the

plans that were being developed. On December 20, 2024, officers, along with the Montgomery County Detective Bureau and Montgomery County SWAT-East Region, executed a search warrant on the individual's resident and arrested the involved party without incident.

On December 17, 2024, a letter was received from the Willow Grove Lions Club thanking department members for their support of the blind community.


On December 18, 2024, an email was received from a resident of Exton Road thanking officers for their handling of a recent traffic complaint in her neighborhood.





Notable news:

In late December SARS took delivery of 13 Stryker LP35 heart monitors and 5 Stryker LUCAS III CPR devices. In addition SARS will be taking delivery of 11 new Stryker stair chair patient moving devices. This purchase replaces equipment that was end-of-life most of which was over 12 years old and some of which was over 18 years old.

The combine purchase price for this equipment is \$775,203 which will be paid over 5 years though a program with Stryker financing.

Training on the new equipment will take place towards the end of February.

SARS is in the process of reviewing quotes for the purchase of new ambulances. Due to current market conditions if SARS were to place an order today delivery would not be until the middle of 2027. The current price of a replacement ambulance for SARS ranges between \$330,000 to \$350,000 and does not include the equipment that must then be placed on the truck.
