Public Health & Safety Committee Meeting

Public Health & Safety Committee Members: Commissioner and Committee Chair Charles M. Whiting, Commissioner Anthony Benvenuti, Commissioner Kip McFatridge; Scott Bendig, Police Chief; Edward Glassman, Fire Chief; Kenneth E. Davidson, Assistant Chief Operations & Administration - Second Alarmer's Rescue Squad (SARS)

- I. **Call to order:** Commissioner and Committee Chair Charles M. Whiting called the meeting to order.
- II. **Roll Call:** Commissioner and Committee Chair Whiting and Commissioner McFatridge. Absent: Commissioner Benvenuti. Fire Chief Glassman, Police Chief Bendig. Absent: SARS Assistant Chief Davidson. Also present: Patrick T. Stasio, Township Manager, and Sean Kilkenny, Township Solicitor.
- III. **Announcements** – Nothing to report.
- IV. **Public Comments – Non-Agenda Items Only** - Nothing to report.
- IV. **Approval of Minutes – May 12, 2025:**
The Committee unanimously approved the meeting minutes as submitted.
- V. **Acceptance and approval of the following monthly reports – May 2025:**
 - A. Police Department – Memorandum and Monthly Reports: Police Chief Bendig discussed the following:
 - Statistics and details from services, trainings, criminal investigations, traffic enforcement, school bus violations, community events, commendations and thank you letters included in the report.
 - Teen Driver Safety Seminar will be held on June 17th and June 24th at 6 p.m.
 - Junior Police Academy will be held July 30-31 at Pileggi Park, 8:00 a.m. to 4:00 p.m. Registration is through the Parks and Recreation Department website.
 - B. Department of Emergency Services – Fire Chief Glassman discussed the following:
 - Statistics and details from services, fees, significant incidents, participation in meetings, and community events included in the report.
 - Thanked the Police Department and Township staff for work at the June Fete event.
 - C. Second Alarmer's Association and Rescue Squad – A report is included in the meeting book and nothing further to discuss.
- VI. **Old Business** – Nothing to report.
- VII. **New Business:**
 - A. Parkside Avenue and Magnolia Avenue Four-Way Stop Sign Request – Chief Bendig reviewed the following:
 - Based upon a recent speed study and crash data, the placement of a Stop sign at the intersection does not meet PennDOT's warranted standards. At this time, there is no recommendation to install a four-way Stop sign.
 - Officer Andrew Misner explained level one measures that include lining the roadway,

painting the roadway, and parking spaces off to the side which makes the roadway narrower. Level two measures include speed bumps or adding chicanes. Summarized findings from the traffic study and a request to install Stop signs.

- The Committee recommends no action by the Board of Commissioners.

B. Nuisance Ordinance – Chief Bendig discussed the following:

- Upon request made in April, investigated the feasibility of a public nuisance ordinance similar to those enacted in other Pennsylvania communities. Mr. Kilkenny reviewed the concept of a nuisance law and presented the option of exploring the expansion of the nuisance definition under Chapter 223 of the Code. There are several alternatives for the Board of Commissioners to discuss and determine as appropriate.
- Mr. Kilkenny recommended exercising careful consideration with enacting the restriction of rights.
- Chief Bendig monitors complaints in the community, and found that they are not specific to location, the Police are handling issues appropriately, and he will continue assessing concerns to address at a later time.
- The Committee recommends no action by the Board of Commissioners.

C. Submission of State Fire Commissioner Grant Application – Chief Glassman discussed the following:

- The grant is offered to career-only fire departments and requires no matching funds. An application for \$78,000 will be submitted for upgrades to complete building projects that include flooring on the second floor of the south building, HVAC in the north building, a gear washer, and IT upgrades. ARPA funds were also secured. If awarded, two buildings will have been renovated using almost no Township funding.
- The Committee recommends the Board of Commissioners approve at the July 7, 2025 Regular Meeting.

MISSING JUVENILE-ENDANGERED:

On Thursday, June 5, 2025, officers were contacted by the Family Protection Unit of the Montgomery County District Attorney's Office regarding a missing juvenile victim and her infant child. The missing juvenile victim and child had been in the care and custody of the Montgomery County Office of Children and Youth at a shelter in York County. This care arrangement was in reference to an ongoing criminal case that originated in Upper Moreland Township. Members of the Criminal Investigations Division were able to track the whereabouts of the missing juvenile victim to Pottstown. The missing juvenile victim was located and detained by the Pottstown Police Department, but the missing infant was not with her. The juvenile victim was turned over to the care of the Montgomery County Office of Children and Youth. Further investigation resulted in the locating of the missing infant child in the care of an adult associate of the juvenile victim. The infant child was turned over to officers and was placed with a foster family through the Montgomery County Office of Children and Youth.

MISSING JUVENILE-SEXUAL ASSAULT ARREST:

On June 12, 2025, a Philadelphia resident was arrested and charged with involuntary deviant sexual intercourse, unlawful contact with a minor, and related offenses. On May 28, 2025, an investigation was initiated into a missing juvenile from a residence in Upper Moreland Township. Information was developed that the missing juvenile was in the company of an adult homeless male who was engaging in a sexual relationship with the juvenile. The Criminal Investigations Division located the juvenile in North Philadelphia and returned her to her home. An investigation was then initiated into the reported unlawful sexual contact between the two subjects. Crime scenes were identified, located, and secured as part of the investigation and forensically processed. Additional evidence was found of the sexual contact after the offender's cell phone was forensically downloaded. An arrest warrant was obtained for the offender. Information was received indicating that the wanted offender was attempting to meet with another juvenile in North Wales, PA. Officers initiated surveillance of the offender's home, subsequently locating and arresting him in a boarding home in Philadelphia.

ASSIST ANOTHER-DESPONDENT SUBJECT:

On June 16, 2025, officers responded to a residence in the township for a subject on the roof of a home threatening to jump. Upon arrival, officers observed a despondent subject sitting on the edge of the roof approximately twenty (20) feet from the ground. Officers were directed to a bedroom in the residence where the subject had gained access to the roof. Officers and personnel from Second Alarmers Rescue Squad initiated a conversation with the subject, additionally positioning themselves to be ready to attempt to grab the subject if she tried to injure herself. When presented with an opportunity, personnel grabbed the subject and pulled her to safety into the bedroom through the window. The subject was placed into protective custody and transported to Abington Memorial Hospital for a medical and mental health evaluation.

FIREARMS VIOLATION:

On June 18, 2025, officers conducted a traffic stop of a red Acura on Maryland Road for registration and inspection violations. Officers approached the vehicle and spoke with the operator and sole occupant. Officers noted the operator's nervous behavior and marijuana residue on the rear seat of the vehicle. Officers requested written consent to search the vehicle, which was granted. A search of the vehicle was initiated, resulting in the recovery of a loaded stolen semiautomatic firearm in a void directly under the steering wheel. The operator was taken into custody and charged with firearms violations and related offenses.

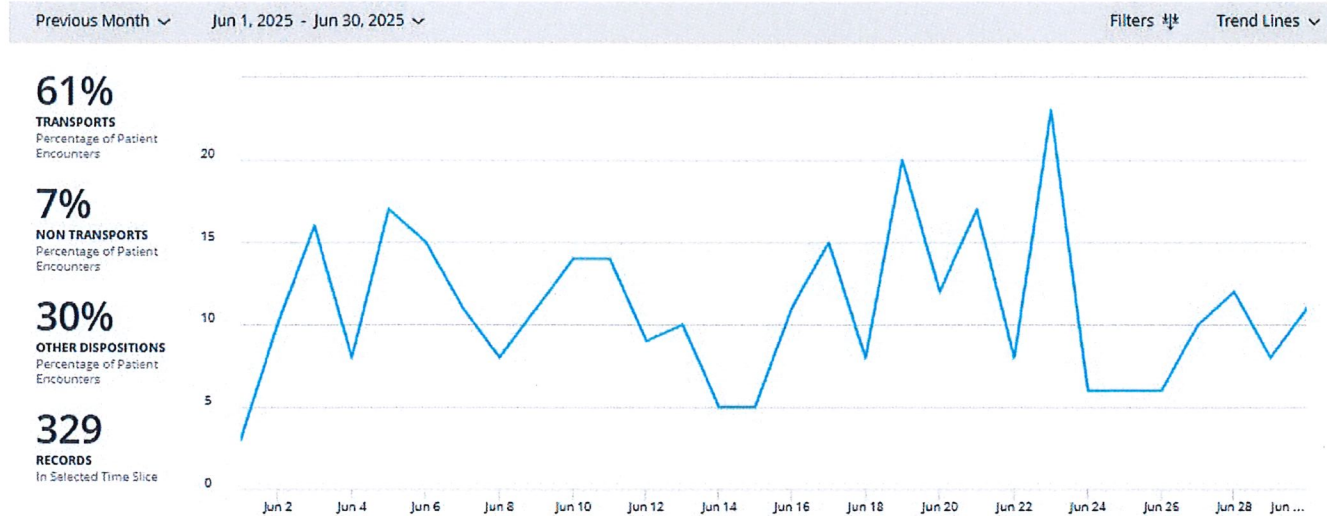

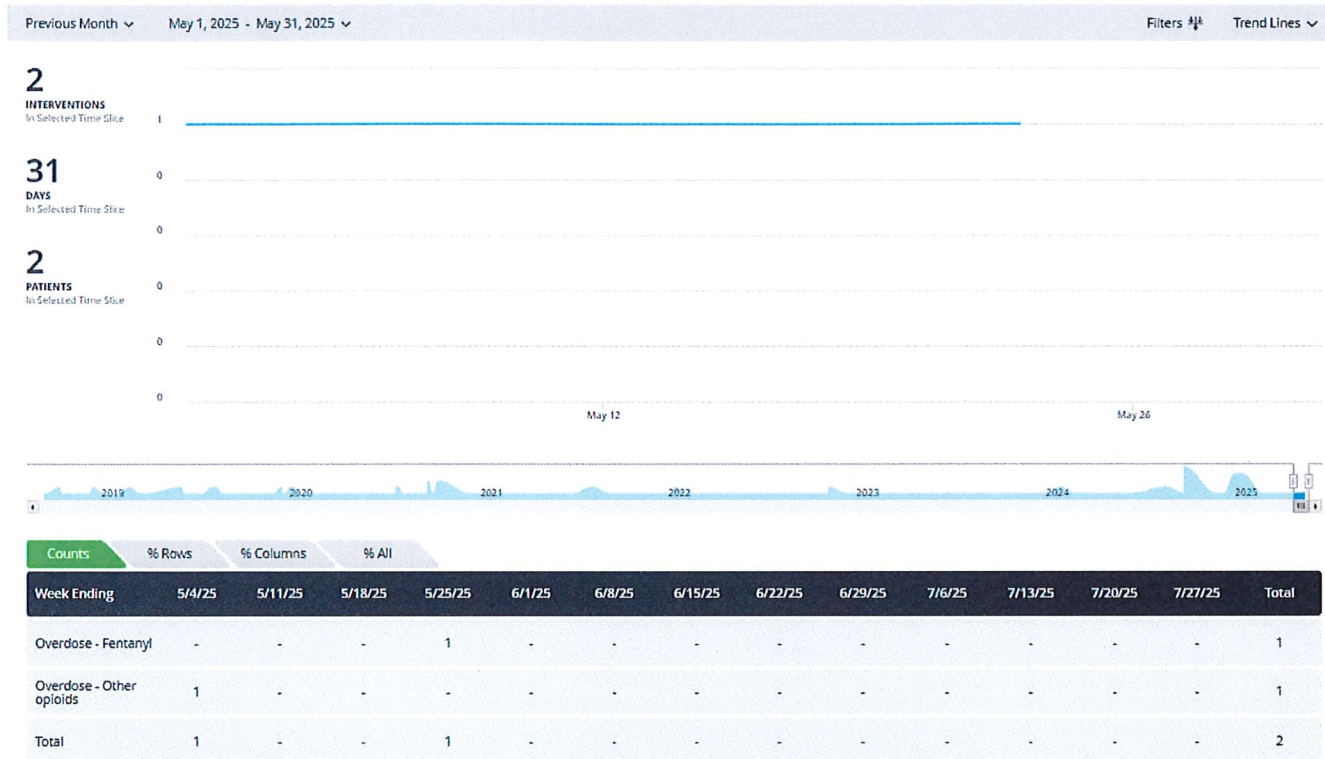

Notable news:

- SARS currently has 4 full-time positions open, and we are looking to increase our per-diem staffing as well. This is reflective of the regional EMS provider shortage. It continues to become harder and harder to recruit and retain EMS providers as many are leaving the field for better paying occupations.
- SARS plans to take delivery of our next new ambulance sometime in August or September.
- SARS EMT class will be started June 24th and currently has 6 students enrolled
- SARS continues to ask that as many area residents as possible contact their state representative and urge them to support House Bill 1152 which provides for patient protection, direct payment to EMS, and a state regulated fee schedule for 911 EMS response.

Background/Analysis:	<p>On July 7, 2025, a complaint was received concerning vehicles parked along the south side of Turnpike Drive. In its current form, the township ordinance permits the parking of vehicles on this section of Turnpike Drive. Concerns do exist regarding an obstructed sight distance and restricted turning movements for vehicles exiting businesses situated along the south side of Turnpike Drive.</p> <p>Representatives from affected businesses have expressed support for implementing a parking prohibition extending from the intersection of Turnpike Drive and Davisville Road. They have indicated that such a measure would not negatively impact their operations and would likely enhance overall traffic safety and accessibility.</p>
Fiscal Impact/Source:	None
Alternatives:	Maintain the current parking prohibitions on Turnpike Drive as currently ordained.
Recommendation Action:	The police department recommends that parking be prohibited along the entire length of Turnpike Drive from the intersection of Turnpike Drive and Davisville Road.
